Davies presented the latest crime statistics for Marchwiel/Cross Lanes area. Then invited any questions from Members. No questions from the member of the public

present.

73.25/26 PUBLIC CONSULTATION FOR BUTTERFLY (GLÖYN BYW) SOLAR FARM –

RWE representatives to update members and take questions. We're currently at the formal consultation phase, which is running from the 15th of September to the 27th of October, and we're holding 5 in-person events. After we've done these consultations, we plan to submit an application to Planning and Environment Decisions Wales (PEDW) by the end of this year. A recommendation of approval, or to deny the project in 2026 as outcome. If it is consented, it would be start to be built in 2027. The revised plan includes – Western Array, additional wet woodland, we've increased the hedgerow planting along the public rights-of-way, and we've removed the information boards which was a request from a nearby resident. Central Array, we've removed this field here, of panels, and that's now going to become an orchard. We've also introduced two kilometres of permissive path on top of what we already introduced, and we've removed an access road

here as well, so no construction deployment down there. And we've also increased the screening with hedges and some more tree planting as well. Eastern Array, We've removed this field completely, from our red line. Again, introduced more permissive paths, and introduced an offset at the top where that yellow arrow is. We've pushed the panels back here and introduced trees. From resident input, main concern was about the offset, we've put in a 45-metre offset with a double stagger tree belt. This will really effectively screen any user panels. Then opened to questions. SL asked if panels could be sited on higher ground rather than use good lowland productive land. The power pick up to the grid is the main factor as where arrays are located. MR asked what is to stop adding more arrays going forward. The Legacy capacity (grid pick up) is the limiting factor and it will all be taken up with this scheme. KG asked about harmful effects on the planet to make the components. In terms of the carbon payback, typically a site like this, you're looking about 1 to 3 years before it repays its carbon, that it costs to sort of build it. That includes manufacturing the panels, getting the panels over here, delivering them. In principle PM supports solar energy as a useful source for electricity generation. A member of public queried the level of construction traffic and laying the underground cable with disruption to traffic. In reply, about 24 deliveries a day, across 6 entrances. So, that's typically 1-2 lorry deliveries every hour, during that period, for about 9 months. So, one to two lorries every hour. Around 20 working days to install the ducting for cables and not anticipating major traffic disruption. RWE will make good any damage to roads – using a before condition survey as reference. Feedback forms were left in case anyone is not able to attend consultation event. Thanks given for taking the time to attend this meeting. If members wish to review what MCC has already submitted, possibly put on the agenda for next meeting with RWE agreeing an extension and decide if we need to comment further based on the update today - ALL AGREED.

Specialist advice from the One Voice Wales Biodiversity team is being sought but in the meantime a trim might make the area more accessible. PM has helped with a broken rail repair and has done some clearance of paths already. SJ proposes a repeat of the volunteer effort to par back the reeds and make all the boardwalks accessible, a number of members agreed to help.
