AGS Assertion 1.

To expand on our response we have reviewed Theme A and C of the Finance Governance Toolkit (V1.1 November 2022) and have adopted a **Vision & Purpose Statement**. We have a published Biodiversity Plan – see www.marchwiel.org.uk on the Home page. We have also published our first **Annual Report 2025/26**. A formal Community Engagement Strategy is being brought forward and currently we rely on regular conversations with residents to bounce off current thinking to ensure it has general approval. Marchwiel CC have not, as yet, adopted a Welsh Language scheme but are very mindful that, when asked, we make best efforts to accommodate residents that prefer to use the Welsh language. We are happy to translate documents if requested to do so and where official notices are supplied in both English and Welsh they are displayed online and in the community notice boards. We meet all the requirements to communicate via our website and Facebook page. We have a complaints policy, reviewed annually, in place and will draft a Social Media policy in the very near future.

Our vision is to perform properly the 1st Tier Local Government function as 1st base and then to look at a step change for the Council, it needs to balance ambition with available resources. The Community of Marchwiel will be consulted as it is anticipated that the Precept level will rise to meet what the Community strives for, an attractive place to live with amenities to match.

AGS Assertion 2.

We have an adopted Code of Conduct for members, Council Officers and Employees Officers (such as the Clerk) are bound by the Code of Conduct (Qualifying Employees of Relevant Authorities) (Wales) Regulations. This requires employees to:
