AGS Assertions 1 - 9.

For the best part of 3 years MCC have had severe resource constraints as their single employed person was not able to undertake the full functions of Proper Officer/Clerk/Responsible Financial Officer. MCC appointed a Locum Clerk on 2nd February 2024 and a turnaround action plan was begun.

We have answered “No” to all 9 assertions on the Annual Governance Statement. As a Council we were not able to meet and our single employee was unfit for work for the most part.

Additional disclosure notes*

The following information is provided to assist the reader to understand the accounting statement and/or the Annual Governance Statement

1. Expenditure under S137 Local Government Act 1972 and S2 Local Government Act 2000

Section 137(1) of the 1972 Act permits the Council to spend on activities for which it has no other specific powers if the Council considers that the expenditure is in the interests of, and will bring direct benefit to, the area or any part of it, or all or some of its inhabitants, providing that the benefit is commensurate with the expenditure. Section 137(3) also permits the Council to incur expenditure for certain charitable and other purposes. The maximum expenditure that can be incurred under both section 137(1) and (3) for the financial year 2022-23 was £8.82 per elector.

In 2022-23, the Council made payments totalling £2219.50 under section 137. These payments are included within 'Other payments' in the Accounting Statement.




Auditor General's report and audit opinion

I certify that I have completed the audit of the Annual Return for the year ended 31 March 2023 of **Marchwiell Community Council**. My audit has been conducted on behalf of the Auditor General for Wales and in accordance with the requirements of the Public Audit (Wales) Act 2004 (the 2004 Act) and guidance issued by the Auditor General for Wales.

Audit opinion: Qualified

Except for the matters reported below in my Basis for Qualification, on the basis of my audit, in my opinion no matters have come to my attention to give cause for concern that, in any material respect, the information reported in this Annual Return:

- has not been prepared in accordance with proper practices;
- that relevant legislative and regulatory requirements have not been met;
- is not consistent with the Council's governance arrangements; and
- that the Council does not have proper arrangements in place to secure economy, efficiency and effectiveness in its use of resources.

Basis of Qualification

Accounting Statement

I am unable to conclude whether or not the Accounting Statement properly presents the Council's receipts and payments and financial position:

- The Council's former Clerk failed to maintain proper accounting and other records eg burial records. Therefore I am unable to conclude whether or not the Accounting Statement provides a complete summary of the Council's finances.

Other matters and recommendations

I draw the Council's attention to the following matters and recommendations which do not affect my audit opinion but should be addressed by the Council.

Annual Governance Statement

The Annual Governance Statement sets out the minimum governance standards expected of a council such as Marchwiell. A series of negative responses indicates that the Council has failed in its duties to properly manage its affairs and to safeguard the public funds it is entrusted with.

I draw attention to the extensive negative responses provided by the Council. For a number of years, the Council experienced difficulties with its former Clerk who failed to discharge her role. The Auditor General had previously issued recommendations

for improvement following an extraordinary audit of the 2011-12 to 2017-18 financial years. However, it is clear that the Council did not take the necessary action to address the failings of the former Clerk.

Looking forward, the current Clerk has taken steps to improve the Council's records and I have issued an unqualified opinion for 2024-25. Nevertheless, the Council should continue to monitor the annual accounts process to ensure it does not experience similar issues again.

There are no further matters I wish to draw to the Council's attention.
