BURIAL GROUND REPORT – SJ advised that members that the repairs needed after two trees were blown down have been quoted for. Under the delegation approved SJ negotiated a figure of £1350 for removal of the tree stumps, kerbing repair, re-setting of affected memorials and other works. The wall repair was quoted for by 3 parties. The lowest quote of £700 was accepted after references on quality of work were taken up. This should be completed over the coming weekend. In addition, one of the trees earmarked for removal as it is unsafe, under the approved planning application P/2024/1537 is now being treated as a priority. The contractor has quoted £400 and is expected to remove by the weekend. Other outstanding works are the hedge to be lowered and the crown lift of the Cherry Trees by the Peace Memorial. Quotes are now being requested. Some monies, £3,900.00, outstanding to the Council has been received, historic fees for burials and/or memorials installed. PM queried if an insurance claim had been considered. SJ was minded not to claim as the renewal premium would likely jump. If members decide that a claim is preferred this can be actioned.

LOCUM CLERK REPORT - INCLUDES CORRESPONDENCE -

- The latest Police Report was presented. 2 instances of anti-social behaviour reported in the month.
- An email from Jacinta at WCBC is suggesting a session to weed around and mulch each of the sapling trees planted last November. Encourage the volunteers that helped last year to come along. Posters and Facebook posts could help get the word out. SJ will see if a date can be suggested.
- Correspondence from the organisers of the National Eisteddfod to take place in August in Wrexham. They talk of a Decorating Project to make the route to the Maes attractive. Publicise on MCC channels.
- Street Lighting matters recent email exchanges with WCBC team over monies owed by MCC. There are six columns condemned and WCBC quote over £15,000 to replace. Scottish Power are also in the mix for service transfer. SJ exploring all options to contain/reduce the cost quoted. Also now getting some quotes for the unmetered supply to potentially reduce the monthly bill.
