Minutes of the Full Council Meeting held at 6:30 pm on **Wednesday 14<sup>th</sup> January 2026** in Piercy Hall, Marchwiell.

Present: Cllrs Davies (CD), (Vice-Chair); Downes (PD); Francis (CF); Grives (KG); Lydford (KL); Marriott (PM); Ogden (MO) & Rathbone (MR) via Zoom.

In attendance: Shaun Jones (SJ), Locum Clerk/Responsible Financial Officer, thirteen Members of the Public & Cllr. John Pritchard WCBC (JP).

116.25/26 **COUNCILLOR VACANCY TO BE FILLED BY CO-OPTION** – Sontley Ward has each a vacant seat. To receive written applications for the office of Community Councillor and to co-opt a candidate to fill the seat – SJ advised **one received. Mrs Patricia Downes was duly co-opted to fill the Sontley Ward vacancy.**

119.25/26 **PUBLIC SPEAKING/QUESTIONS AT COUNCIL MEETINGS** – 13 members of the public present. A resident set out why there are concerns with regard to a scheme to plant trees on a 2.12 acre site and a new pond with an area of 0.62 acre on a piece of land owned by Wrexham CBC behind Marcella Crescent. The residents believe they should not have been kept in the dark over the plans.

120.25/26 **MINUTES** – To approve for accuracy and sign the minutes of the **Full Council** meeting held on Wednesday 10th December 2025. - **Approved by all members present.**

121.25/26 **WREXHAM COUNTY BOROUGH COUNCILLOR'S REPORT** – WCBC Cllr. John Pritchard reported that :-

- Based on the two schemes, just raised by residents here present, to improve the overall tree canopy in Wrexham County JP understood from Jacinta Challinor then of WCBC that affected householders would be consulted with over the tree planting scheme. By the numbers present this evening it transpires only one householder is known to have had a conversation with Jacinta around November 2024 when the Phase 1 planting was underway.

- Phase 2 commencing November 2025 JP explained that there has been no engagement over any elements, pond, footpaths or planting – nothing. He then explained that he was supportive of tree planting on these fields owned by WCBC to prevent any further housing development – seen as the least worst option. **JP along with your Community Council will endeavour to obtain a clear picture over the concerns expressed.**
- Pleased to advise that work on the fence along Station Rd and the football pitch has been renewed and a replacement gate near to the Changing Block installed. A lot tidier than before.
- Follow up on 2 highway street lights on the A525, by Red Lion and Penyllan Farm – both reported needing repair. **JP and SJ will keep in view.**
- Notice of a possible government grant scheme that MCC should look to apply for. Details will be made public soon.

**BUDGET REVIEW AND PRECEPT APPROVAL FOR 2026/27** – SJ walked members through the Cost Centre headings and noted actual expenditure to date against budget. Overall we had budgeted an estimated spend of £61,862 and the actual spend is £34,210.09 so far. Historic VAT to be claimed for 2024/25 forward, £3,668.07 - 1.75 years in all, will provide a decent catch up in funds.

undertaken – known as virement. The overall budget is unchanged, just re-distributed.

- Income is out-looked at £5,500 for the Burial Ground and £5,000 drawn from Reserves. The precept request of the householders in Marchwiell is calculated at estimated spending of £65,000 less income and reserves drawing, £10,500 equals £54,500. For a Band D householder their annual contribution is £91.75 up by £3.96 (or £0.08 per week) to the MCC budget.

**Members approved the final budget of £65,000 for FY2026/27 and the Precept request of £54,500 to underpin.**

**Also noting the Council Tax Base letter issued by WCBC Finance Dept.**

**FINANCE MATTERS – To determine the following:-**

- SJ recently met with the Audit Wales person looking at all three Annual Reports presented, for 2022/23, 2023/24 & 2024/25 financial periods. We met over zoom and the discussions lasted around 2 hours. Particularly the Full Audit – 2023/24 has four points for clarification. Firstly an invoice paid for works on the Nature Reserve and if alternative quotes were required or other matters in the Financial Regulations could be relied on. Point two is a query over four burials in the period and provision of supporting documents and images (if applicable) of the grave space. Point three is to provide a statement from AVOW showing the shortfall amount that was cleared by cheque. Point four is to draw a correlation between the amounts insured on our insurance schedule to the published fixed assets register.
- Present Monthly Bank Reconciliation – December 2025 reports and sign off. **Reviewed the Scribe summarised information page and signed off the Bank Reconciliation report.**
- Present Q3 [April - December 2025] Expenditure against Budget report and sign off. **Reviewed and approved.**
- Equals Pre-paid Creditcard account closed due to the introduction of a £25 monthly fee (previously fee free) and research on a replacement. **Noted & that an application to Barclaycard for a commercial credit card is in process.**
