Minutes of the Full Council Meeting held at 6:30 pm on **Wednesday 8th July 2026** in Piercy Hall, Marchwiell.

In the absence of both Cllr. Sharon Lloyd & Cllr. Clare Davies members approved that Cllr. Cim Francis will Chair this meeting – Carried.

41.26/27 **DECLARATIONS OF INTEREST** – None given.

42.26/27 **PUBLIC SPEAKING/QUESTIONS AT COUNCIL MEETINGS** – 3 members of the public present. Council was addressed on the following matters, these were received by members.

1. The recent news article and determined Scoping Document by Wrexham CBC planning team regarding a Proposed development of 14 Industrial Buildings along Sesswick Way submitted by Mauna Kea Ltd (the Net World Sports Ltd development company) was raised.
2. It is noted no planning application has been lodged.
3. It is noted as loss of 33.61 hectares of prime (grade 3A) agricultural land and the proposed scale (up to 23 metres in height, noise/light/traffic pollution).
4. Plans to form an Action Group in Marchwiell and surrounding area to object and seek the full support of Marchwiell Community Council to back the group.
5. A contribution from a resident adjacent to the proposed development spoke and confirmed discussions with adjacent neighbours. In the cancelled WCBC LDP this land was discounted as land for development. This led to a number of ownership changes – it is believed. After submitting an email about the initial concerns the owner of Net World Sports paid a visit. Going forward the

- 44.26/27 **WREXHAM COUNTY BOROUGH COUNCILLOR'S REPORT** – By email WCBC Cllr. John Pritchard reported that :-
 - Mention of the Scoping Report SC/2026/0001 – see Agenda Item 49.26/27
 - Bus Stops on A525 at both ends of the village have been tidied and greenery clipped back.
 - WCBC Housing Dept. have cleaned the footpaths behind Maelor View. Also an unsafe wall has been demolished on Maelor View bungalow site. Also a new bench is to be sited along Maelor View – funding from WCBC Environmental pot that the local member can access.
 - The clearance of green encroachment on the pavement from Cross Lanes traffic lights to Pick Hill should be completed soon.
- 45.26/27 **PRIDE IN PLACE IMPACT FUND** – SJ reported on progress of application to date :-
 - Emailed 12th June to Ceri at WCBC Grant Administration team. Land owner permission is proving difficult to obtain. Also there is a query over improving the road surface at the bottom of Station Road.
 - A reply was received today, Includes reference to additional WCBC contacts to request land owner permission from.
 - SJ asked if any member had any bandwidth to help with pushing through the application pre-requisites – this would be most welcome.

PRE-APPLICATION SCOPING APPLICATION – 33.61 HECTARES

ENVIRONMENTAL IMPACT ASSESSMENT – LAND WEST OF SESSWICK WAY, WREXHAM

– A recent news article <https://wrexham.com/news/net-world-sports-reveals-plans-for-major-expansion-in-marchwiel-294572.html> has alerted residents of a proposal to submit an outline planning application on land adjacent to Five Fords Water Treatment Works. Some 14 Industrial Units some as tall as 23 metres. The Locum Clerk summarised some information extracted from the supporting documents submitted with the pre-application scoping application.

- An outline planning application is likely to be the next formal step.
- From the Scoping Report at 4.43 there is mention of the Utopia City full planning application (P/2023/0497 – not yet determined – Holt Community Council area), in reference to the 23m height and wind microclimate. Simply to say no assessment of wind aspects was called for in that case and they have higher buildings proposed.
- Using Google search and AI tool, suggestions on approach and specific matters to include in any letter of objection being drawn up. A copy will be distributed to members.
- Keeping close touch with WCBC Cllr. John Pritchard to have him as a go-between [WCBC Planning Team and MCC].
- Establish a channel with Holt/Sesswick Community Councils.

Members agreed to support the residents who have their concerns over this proposed development and liaise with neighbouring Community Councils to bring pressure to bear on securing a result where the agricultural land is retained – no development, or if that is not possible for a modified proposal that has the lowest impact on the environment and visual impact – Carried.

LOCUM CLERK REPORT – INCLUDES CORRESPONDENCE – *To receive an oral report.*

- PCSO Lisa-Marie Davies is present. She presented the monthly crime report for June – 4 reported incidents. SJ also mentioned the request from WCBC Cllr. Pritchard to be alert to suspicious activities being reported taking place at the bottom of Station Rd. A number of members also raised concerns over electric scooters and bike riders with little or no road sense. All noted by Lisa-Marie and members thanked her for attending.
- The offer to replace a bench in the Burial Ground by a local family is progressing. We will suggest who could be approached to help with the installation.
- WCBC survey on Rock Salt Bins sited in the village. SJ will respond.

- WCBC Speed Indicator Displays survey. There are 2 on A525, on either side. SJ will respond.
- We have been alerted to inconsiderate parking near to pavement road crossing points (the bobbly sections) which makes access for mobility scooters/wheelchair users extremely tricky. **SJ will alert the PCSO team to ask them to closely monitor.**
- The WCBC Public Space Protection Order has now formally been readopted – covers City Centre.
- Note of social media posts on obstacles on the Recreation Ground – possibly mole traps – then removed, as Wrexham Council, being the owner may not have approved.
- Marchwiell Saints FC – correspondence from their Chairman – giving an update on recent highlights – Development of age banded children’s teams and a new Adult Team is being established – to compete in North East Wales Division 3. PD has put her company forward to be the shirt sponsor (home kit) and is impressed with the development noted. Mention of the recently held Football Tournament where numerous teams visited Marchwiell to compete. Rose Fox also played a blinder by undertaking a clean-up around the changing room block. All members thanked her. **CF will introduce a local company to the Football Club Chairman in the hope they will also agree some sponsorship of the Away Kit.** Members also agreed to approve a grant of £100 toward the cost of footballs. **SJ will make the bank transfer soonest.**
- Ian Pope of Rainbow Centre replied to our request for more information on the Café Pilot at Piercy Hall. Some discussion on the plans by members took place. **Members agreed to make a donation of £160 to source additional crockery that is deemed “dementia friendly”.**
- Email from Deryck Evans of Audit Wales highlighting some early submissions for External Audit are incomplete and the note was to hopefully guard against more following.
- An email regarding the King’s Birthday Honours List 2027 and putting forward nominations by 7th August 2026.
- Letter of introduction from recently elected Senedd Member for Flint Wrexham Mr Sam Rowland – one of the six elected. **SJ to reply and make an invitation to attend a future meeting.**
- UK City of Culture Bid Team 2029 have written to outline promotional materials for the bid. **SJ to reply with information requested.**
