14 S137 Payments

Precept Payment Schedule & Taxbase 2019/2020 (Taxbase = 590)

The Clerk reported to Members that the appropriate sum for the purposes of section 137(4)(a) of the Local Government Act 1972 (the 1972 Act) for Community and Town Councils in Wales for 2018-19 is £7.86. The maximum expenditure that can be incurred under both section 137(1) and (3) for the financial year 2018-19 will be £7.86 per elector.

Section 137(1) of the 1972 Act permits each Community or Town Council to spend on activities for which it has no other specific powers if the Council considers that the expenditure is in the interests of, and will bring direct benefit to, the area or any part of it, or all or some of its inhabitants, providing that the benefit is commensurate with the expenditure. Community and Town Councils are also permitted under section 137(3) to incur expenditure for certain charitable and other purposes. The maximum expenditure that can be incurred under both section 137(1) and (3) for the financial year 2018-19 will be £7.86 per elector. Maximum total allowed = £4,605.9618/19 **Precept Resolved a maximum of £3,000 which is under the maximum allowed.**

Resolved that, in accordance with Council policy, applications for financial assistance from organisations be considered once a year in May. Members RESOLVED the following organisations be paid the amount stated below:-

St Marcella Marchwiel Church £250; Nightingale House £100; Hope House £100; Llangollen Eisteddfod £100; Dynamic £75; Rainbow Centre Penley £150; Vic Studios Ltd £50; Home Start £50; Family Friends £50; Wales Air Ambulance £100; Cherish Wrecsam SCBU (Wrexham Special Care Baby Unit) £100; WRVS £50 = **Total £1,175** The Chairman's Fund £300.

Members made No Objections.

Members decided they would like to purchase their own unit on a stand and place it at the bottom of Station Road near the rockery. Members discussed at length where to place their own defibrillator.

Members RESOLVED to purchase their own defibrillator to be positioned in Marchwiel. They agreed an estimated price of no more than £4000 for the defibrillator, the case and fixing into situe. The Clerk agreed to obtain information of different systems and obtain quotes.

21 Street Lighting

Clerk reported emailing Allan Richardson from Snapfast again asking if he could begin the process of applying for funding for the 69 led lamps from his company and give the process of the procedure.
